- The manufacturer must keep at the manufacturing plant a set of plans and specifications bearing the department's stamp of approval. The plans and specifications must be open to inspection by an authorized representative of the department.
- Installation and servicing of this product must be in accordance with the manufacturer's instructions. A copy of the manufacturer's installation and servicing instructions must be given to the owner of the system.
- This product may not be installed more than 36 inches below final grade.
- A minimum 2" diameter vent must be provided on the building sewer within 12" of the connection to the tank or on the tank installed in accordance with the manufacturer instructions.
- BEDDING: Compacted aggregate conforming to tank base at depth and diameter as per manufacturer's installation instructions; dewater excavation prior to installation.
